(1) CLOSE DATE: December 1, 2018. Trip is subject to availability.

(2) FULL PRICE: Golfer, sharing room- €4,050 Euros. Non-Golfer: €3,550 Euros. Golfer, single room- €5,170 Euros. Pricing is based on 24a participants; if fewer participate, cost per participant will increase.

(3) DEPOSIT: A deposit for each participant must be received upon sign-up or when the trip is full (24 participants). **Please note USD Rate will be based on exchange rate of the day. Euro Prices remain fixed.** Participants will be contacted ahead of deposit being processed.

(6) AIRFARE: Airfare is not included in this package. Participants are responsible for arranging their own air transportation. **A valid passport is required.**

(8) CANCELLATIONS: Full refund of deposit given only if written notification is received on or before May 1, 2018. Cancellations received after May 1, 2018 will forfeit the deposit. WGA will make best effort to fill vacancy to permit a refund.
